Please submit 5 images (5MB or smaller) of artwork that has been created in the last 3 years and not previously shown at the Main Line Art Center. 3 of the 5 images need to be available for the exhibition in January 2016 if selected. All entries must be submitted electronically via http://mainlineart. slideroom.com by 11:59 PM, October 6th to be accepted into the 2016-2018 PAM membership and exhibition.
